An Act amending title 25 Virgin Islands Code, chapter 16, section 405 relating to the mooring and anchoring of vessels in the Virgin Islands to provide for increases in the fee schedules

1 Be it enacted by the Legislature of the Virgin Islands:

2	SECTION 1. Title 25 Virgin Islands Code Chapter 16, section 405 is amended in the
3	following instances:
4	(a) The title is amended after "Mooring" by inserting "and Anchoring";
5	(b) Subsection (a) is amended
6	(1) in the second sentence by striking the phrase "under section 403 of; and
7	(2) in the third sentence by striking "an annual fee of five dollars (\$5.00)" and
8	inserting " a fee";
9	(c) Subsection (e) is re-designated as subsection (g) and amended by striking the first
10	sentence in its entirety;

(d) A new subsection (e) is inserted and reads as follows:

- 2 "(e) The vessel mooring fees and the vessel anchoring fees are as established in
 3 Schedules I and II of this subsection.

The current mooring fee is set at \$5.00 per foot per vessel regardless of the type of use. The proposed mooring fees are \$10.00 per foot length for Pleasure Vessels, \$15.00 per foot for Live-Aboard Vessels and \$20.00 per foot length for Commercial Vessels per year.
