BIR Publication of Names of Delinquent Taxpayers

The following list is being published pursuant to section of 8(a) of Act No. 7261, the Economic Stability Act of 2011, which states that the Bureau has been authorized to publish in a generally circulated newspaper, the names of all businesses and entities and the owners thereof, that are delinquent on the payment of gross receipts, hotel occupancy and excise taxes for over 6 months as of the date of enactment of this bill. The bill was signed into law on July 5, 2011. Taxpayers appearing on these listings are delinquent as of January 2011 and should contact the Bureau's collection division to arrange to pay the full amount of the delinquency, or to establish a payment agreement. Taxpayers listed who wish to establish payment agreements are required to file all past due returns, which are currently accruing interest at the rate of 1% as well as a failure to file penalty of 5% per month. Taxpayers who believe that they have satisfied this liability are asked to provide proof of payment. St. Thomas/St. John District taxpayers may contact the Bureau's offices by calling 714-9320. St. Croix taxpayers may call 773-1040 extension 4254. Taxpayers listed who fail to address their delinquencies will be subject to lien filing and enforced collection activity, to include procedures to extend the 10-year collection statute.
