

Sampling Results

These neighborhoods were part of the 36 samples that tested above the action level for lead and copper in the first and second round listed as “Impacted Areas”. It is important to note that also within these areas, some samples tested below the action levels of lead. **For all 36 samples, after 10 minutes of flushing, test results were significantly below the action level, while some were undetectable.** The 5 sites listed have been sampled and tested below detection limit.
